Thursday, October 23, 2025 • Arrival - Parma - Bologna • Lunch • Hotel I Portici

Upon arrival at Milano Malpensa airport, we will be met by our English-speaking tour guide (Valentina) who will welcome us in Italy and assist us with transfer from airport to our reserved hotel in the beautiful Bologna. On our way, we'll stop in the quaint town of Parma for a nice, guided visit of the city and lunch in a local restaurant. After lunch, we will enjoy a visit and wine tasting at Alfredo Bertolani winery.

In the afternoon, continue our journey to Bologna and arrive at our reserved hotel in the city center and check-in. Tonight, dinner is on our own.

Friday, October 24, 2025 • Bologna - Tuscany • Breakfast, Dinner • Villa Campestri Olive Oil Resort

After a tasty breakfast, meet our guide at the hotel for a half-day gourmet tour of Bologna, the capital of Emilia-Romagna and whose essence is food and history. During our tour, discover Bologna's finest fares at the bustling medieval markets of the city – the Quadrilatero, Mercato di Mezzo, Mercato delle Erbe. As we wander around the medieval markets, sample a selection of mouth-watering delights such as mortadella, ciccioli, salsiccia passita, and chocolate- this food tour might be a good substitute for lunch.

After our gourmet tour of Bologna, we will be transferred to Modena for a vinegar factory visit and tasting. Sample and learn about this unique product with a thousand-year history and use in a wide range of dishes.

Continue our journey to the countryside of Tuscany and arrive at the villa where we will be assisted with check-in procedures. This evening, we will have a tasty welcome dinner at the villa restaurant.

Saturday, October 25, 2025 • Tuscany • Breakfast • Villa Campestri Olive Oli Resort

Today, enjoy a full day at leisure to relax at your private Tuscan villa. Villa Campestri is located in the heart of Mugello hills, just a stone's throw from Florence. The estate is arranged according to the original layout of the Renaissance period. The rooms have been carefully restored and furnished with authentic antiques. All the rooms overlook the century-old park and the breathtaking Mugello Valley. In the centuries-old park in the Tuscan hills there are olive groves from which a superior quality olive oil is extracted, directly from centenarian trees.

Sunday, October 26, 2025 • San Gimignano • Breakfast, Lunch, Dinner • Villa Campestri Olive Oil Resort

This morning, we will have the opportunity to enjoy a homemade pasta cooking class experience at the resort followed by lunch. Homemade pasta is a widespread culinary tradition in Tuscany. The villa's chef will reveal secrets to prepare excellent quality pasta. We will make and roll out basic egg pasta dough in many shapes and colors. We might learn how to prepare *potato gnocchi* (nicknamed "little mice" in Mugello) and the *potato tortello*, a specialty of "Mugellana" cuisine.

After lunch, we will be privately transferred by minibus to San Gimignano, a beautiful town nestled between the Sienese hills and the sunny Val d'Elsa hills, surrounded by thirteenth-century walls and rich in still intact medieval charm. Enjoy your early dinner in San Gimignano in a traditional local restaurant.

Monday, October 27, 2026 • Tuscany • Breakfast, Dinner • Villa Campestri Olive Oil Resort

After breakfast at your villa, we will enjoy an Olive Oil Tasting, one of the most important products around the area. Villa Campestri is well known for its dispenser called OliveToLive that preserves the properties of Olive Oil so that its flavor always seems freshly pressed.

After the tasting, enjoy the rest of the day at the resort. This evening, we will have a tasty group dinner at the resort with a guitar performance by Paul Cullen.

Tuesday, October 28, 2025 • Greve • Breakfast, Lunch • Villa Campestri Olive Oil Resort

Breakfast at the hotel

After breakfast this morning, head towards Greve in Chianti, considered the principal town in Chianti. Here we can admire the historic main square where you can browse through numerous artisan and food shops. We'll stop at Verrazzano Castle for a private guided visit to the Castle's gardens and to the historical ageing cellars followed by a guided tasting of selection of their best wines from organic farming, as well as their extra virgin olive oil and balsamic vinegar served on Pecorino cheese, and Verrazzano typical Tuscan "crostini".

Proceed to the village of **Panzano in Chianti**, home to the 'mad butcher' of Chianti, well-known for incredible cuts of meat such as the traditional *bistecca fiorentina* (Florentine T-bone steak) which can exceed four inches in height! –

Group lunch includes a variety of meats and wines. (Vegetarian must be ordered in advance).

Enjoy the rest of the day at leisure.

Dinner at leisure

Wednesday, October 29th • Lucca & Winery • Breakfast, Lunch, Dinner •

After breakfast at the hotel, we head to the scenic Tuscan town of Lucca, known for its well-preserved Renaissance-era city walls that encircle its historic center. The city is rich in history and offers a variety of attractions, including beautiful churches, quaint cobblestone streets, and vibrant piazzas.

After your half day city tour, enjoy a special lunch in a central restaurant in Lucca.

Our journey will continue during the afternoon with a visit to a winery in the surrounding area of Lucca with wine tasting- Tenuta Buonamico. During this experience, we will learn more about the history of the company including visit of the cellar where their staff explain every single phase of the wine making process, tour of the barriques room and the historical cellar. We will then enjoy a tasting. Tonight enjoy a farewell dinner with the group.

Thursday, October 30th • Arrival in Rome • Breakfast, Lunch •

After breakfast at the hotel, we depart by bus to Rome.

Stop along the way for a nice lunch in the area of Orvieto.

After lunch, we re-join our driver and continue our drive to Rome.

Friday, October 31st • Departure • Breakfast •

Today after breakfast, check out of our hotel, and our group will depart for FCO airport for the flight home. Or you can extend your stay and spend more time in Italy!

Cancellation Schedule & Fees:

Original date of deposit to final payment date- First and second deposit is 100% nonrefundable

June 25th 2025 through travel dates- After final payment your payment is 100% nonrefundable, Accent On Travel will also charge a \$250 cancellation management fee

Premium Travel Insurance: Refunds are available for cancellations due to covered medical reasons when insurance is purchased through reliable travel insurance companies. These reputable companies offer insurance that both provides excellent coverage even when the covered medical reason might be a pre-existing condition as well as refund of out of pocket expenses while traveling (each insurance company stipulations outlined in their policy and brochure). You, the passenger, or your immediate family is responsible to file a claim with the insurance company to receive your refund of cancellation penalties for covered reasons from the insurance company. The cost of insurance is not a refundable or reimbursable item but may be able to be transferred to another purchase if the trip is cancelled without the insurance being used.

I accept it is my responsibility to review travel documentation for accuracy including name spellings, dates, and the itinerary and understand that I am responsible to contact Accent on Travel upon receipt if any information appear incorrect. I understand that changing any aspect of my travel arrangements may result in additional fees being applied to my purchase. I have been advised that the name, date of birth and gender that appears on the identification card must exactly match the same such data that is listed on my airline ticket and in my booking records. I understand that the Transportation Security Administration (TSA) requires me to carry a government-issued identification card in order to board a flight. I acknowledge that my failure to strictly comply with these requirements may result in denied boarding or an undue delay at an airport security checkpoint causing me to miss my flight. I further acknowledge that beginning on May 3, 2023, I must present a driver's license or another form of identification that complies with the requirements of the Federal Real ID Act (see www.dhs.gov/real-id for more information).

I understand that Accent on Travel is not the source or supplier of the travel services I have requested and acts solely as an agent for the actual suppliers of such services. I have been advised that the suppliers whose names have been supplied to me are those who are responsible for the travel services I have purchased. I consent to and request the use of those suppliers and agree not to hold Accent on Travel responsible should any of these suppliers: 1) fail to provide the travel services I have purchased; 2) fail to comply with any applicable law; or 3) become insolvent/bankruptcy; 4) claim a freeze on services or payments due to an unforeseen event – Force Majeure, 5) engage in any negligent act or omission that causes me any sort of injury, damage, delay or inconvenience. I understand that the use of a credit card offers me more opportunities to dispute the charge should a vendor cease operating. I accept that Accent on Travel is not responsible for, nor will I attempt to hold it liable for, any injury, damage or loss I may suffer on account of any conditions, actions or omissions that are beyond its reasonable control. I further understand and acknowledge that travel to many parts of the world may involve the risk of a variety of hazards to my health and/or safety, including but not limited to disease, crime, terrorism, and warfare. I acknowledge travel plans may be interrupted or cancelled by the supplier that is providing them, a government entity or a third party over which Accent on Travel has no control. I further acknowledge that the supplier's own cancellation, rebooking and refund policies, subject to any applicable law that is now or may later be in effect, will govern my rights and remedies, including my right to receive a refund, in such an event. I hereby hold Accent on Travel harmless and release it from any and all liabilities for any damages, including but not limited to monetary losses, I may incur as a result of such interruption or cancellation of these travel plans. Because each traveler's risk tolerance is different, Accent on Travel is not able to advise me whether I should travel to any place at any particular time. I understand that if traveling internationally, I must have a valid passport with an expiration date at least six months beyond my planned return travel date and, depending upon my destination and nationality, I may need to obtain one or more visas. Passport and visa information may be obtained by visiting the State Department's Web site at www.travel.state.gov. Non-U.S. passport holders should visit destination/transit embassy sites.

I understand stated price is 'locked in' when deposit confirmation is received by me or when travel is paid in full however I also understand that the cruise line tickets, airline, or other products I am purchasing may be subject to post-purchase price increases due to additional costs imposed by a supplier or government to offset increased fuel surcharges, taxes, fluctuations in foreign exchange markets or any combination thereof. I hereby consent to any post-purchase price increases. Payment for travel is due as advised verbally or in writing by Accent on Travel agent and cancellation with penalties may occur if full and timely payment is not made. Accent on Travel reserves the right to correct any errors and not bound to honor erroneous price or fees and limits liability of negligence to \$1000 or cost of resolution, whichever is less. Client agrees any disputes would be governed in and interpreted by the state of DE if mediation does not resolve the dispute.
